### D. ADDITIONAL TERMS AND CONDITIONS

Travel fees for the Regal Brass will apply to events taking place outside of the New York Tri-State area. Prelude music will begin 15-20 minutes prior to the ceremony. Postlude music will stop 15 minutes after the ceremony or when all guests have left. Additional time or reception music is charged at a rate to be determined based upon mutual agreement of both parties, depending on the request, which would consist of 45 minutes of playing time with a 15 minute break. Reception music is to begin within an hour following the postlude. Any additional time will be considered playing time and charged accordingly. Purchaser must provide 4-5 armless chairs to be placed in the location of performance and enough room for the ensemble so they are not crowded while performing. Due to the delicate nature of professional musical instruments, musicians require shade from the sun and shelter from the rain in outdoor events. Musicians will not perform under direct sunlight, rain or dangerous circumstances. Regal Brass would prefer to rehearse at the event location sometime during the week prior to the event.
